Prices: Our prices are in US dollars excluding freight and insurance, from our US warehouse (Albany, NY). They are subject to revision at

Minimum order: The minimum opening order is \$600. Reorder \$350.

Seller may decline to do future business with Buyer without reason and Seller can decline any reorders from Buyer. Buyer represents to Seller that Buyer is purchasing the goods sold hereunder exclusively for resale from Buyer's stores to retail consumers. Buyer acknowledges that Seller has accepted Buyer's order in reliance on this representation

Freight: We usually ship with Fedex ground and we will bill you for their cost. If you wish to use a different carrier, please give us your account # and we will call the carrier for pick up.

Products: Our products are totally handmade. Despite the care taken in their manufacture, any imperfections or small changes in size or color may exist and are not considered as defects. The goods are purchased on an "as-is" basis and no implied representations or warranties are intended or made by Seller. Pictures, colors and texts of documents are not contractual.

No statement or promise have been made on by or on behalf of Seller to induce Buyer to enter into this Agreement except those specifically

Any defect or non-conformity of the goods ordered must be reported to us within 48 hours of the date Buyer receives goods. No claim may be made or return approved beyond that time limit. No returns will be accepted without our prior agreement.
